

## For Personal Care Residents

### Guidelines for Re-Opening our campus

- We will begin Outside Visits on Monday, August 31.
  - Masks MUST be worn by Residents and Visitors at ALL times for ALL Outside Visits.
  - Residents MUST have masks on at ALL times for ALL Window Visits.
  - Social Distancing (6ft apart) MUST occur at all times for Outside Visits.
  - There is No Touching/Contact during a Window and Outside Visits.
  - There are only two (2) Visitors allowed at an Outside Visit.
  - There is no passing of any food or drink during a Window and Outside Visits.
  - Visitors will be required to sign in, complete our screening form, have their temperature taken and hand sanitize before a visit can occur. Visitors will need to hand sanitize at the end of the visit.
  - Residents will need to hand sanitize before and after the visit.
  - **Should a visitor remove their mask during the visit, the visit will end and the Resident will need to move to our quarantine hall for 14 days.**
  - Outside Visits are for 30 minutes.
  - Nursing Administration will make the determination about canceling a visit time due to inclement weather.
  - Nursing Administration and Social Service will determine the appropriateness of a Resident for an outside visit. Our Medical Director will be involved as necessary.
  - We will continue with Window Visits/Face Time as well.
  - Window and Facetime visits are for 15 minutes.
  - SCHEDULE to start 8/31/2020

Mon – Sun: Visit from 10:30a-11:00am  
3:30p-4:00pm
- Window/Face Time Visits  
M/W/F: 9:30am/1:30pm  
T/Th: 9:30am/1:30pm/6:30pm/7:00pm  
Sa/Su: 6:30pm
- Please come approximately 5-10 minutes early to sign in and have temperature/screening and hand sanitizing completed.
  - Current visits already scheduled will be honored.
  - Visits for the following month, can be scheduled beginning the third Monday of the previous month. For example: Visits for October can begin to be scheduled on Monday, September 21.
  - We are allowing 1/visit week so we can determine how the process works. This could change as we move forward.
  - There are NO inside visits at this time.
  - We will start small group activities (6-8 Residents) on each Unit – 1 Resident/table and 6ft apart in the Dining Room starting 9/3/2020
  - Dining Room service will be 1 Resident/table and 6 ft apart for meals starting with breakfast on 9/14/2020. Other meals will be added at a later date.
  - The Beauty Shop will be 1 Resident at a time starting on 8/31/2020
  - Consulting physician services will be able to visit in a Resident's room starting 8/31/2020. Proper PPE will be required.
  - Church services will continue on the television with NO Communion at this time.
  - There is no shuttle service at this time
